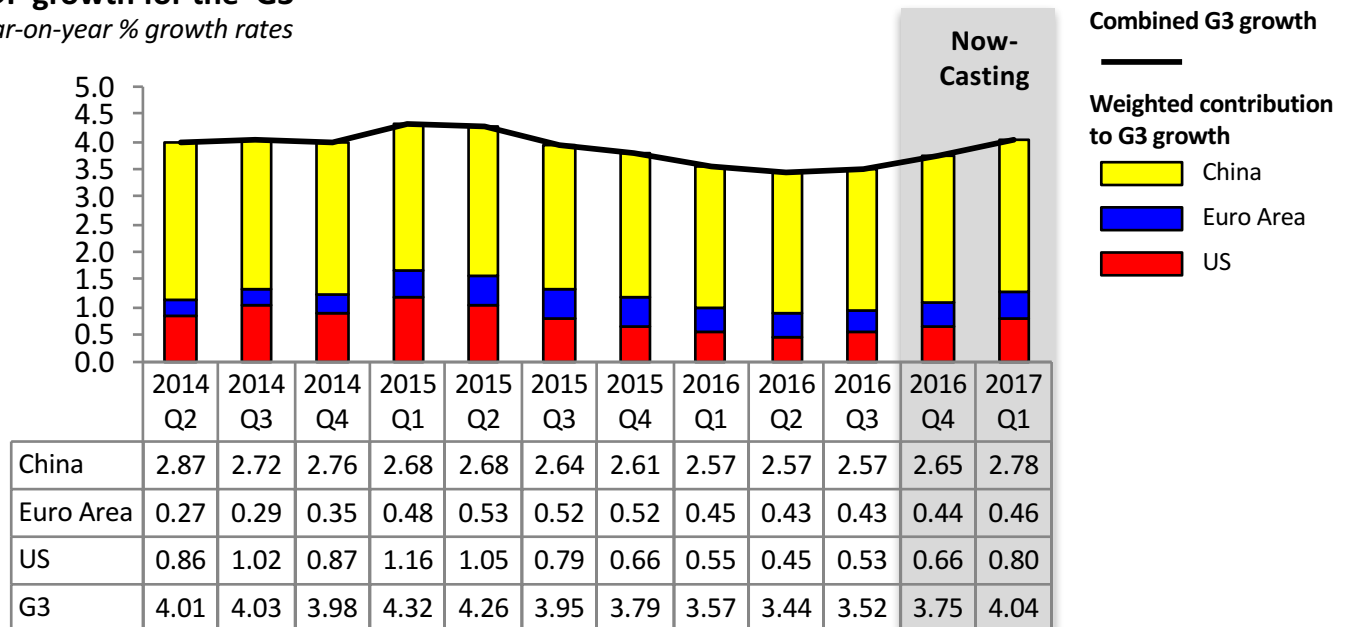

G3 growth on upward trend

- GDP growth for the G3 – the US, Euro Area and China – is expected to be 3.75% in Q4 and to rise to 4.04% in Q41 next year, in each case with respect to the same quarter in the previous year. It is becoming clear that the slowdown in G3 ended in Q2 and that conditions in all three regions have been improving since then
- The change over the past month has been driven by China and, to a lesser extent, the US, while conditions in the Euro Area have been stable

Notes

Release dates In January, April, July and October, G3 GDP estimates are published on the same day as the official publication of GDP growth in China; in all other months they are published on the 15th of each month or the first working day thereafter.

Growth rates All quarterly growth rates mentioned in this release are calculated on a year-on-year basis: comparing the reference quarter with the same quarter in the previous year

Weights The US, Euro Area and China are weighted by their share of G3 total GDP in 2014, according to the IMF World Economic Outlook April 2016 database, using current international dollars, at purchasing power parity

Forecasts are produced automatically, without judgment or other intervention. The deep parameters of Now-Casting model are re-estimated at the beginning of every year
